The lessor is the owner of the building 52/179 Ek Prachim Alley2 Paholayothin Rd. Lak Hok Sub-District Muang District Pathumthanee 10200. Hereinafter this agreement call "asset"

Both Parties agree to contract as follows;

- 1. The Lessor agree to lease and the Lessee agrees to take a lease in the building which is asset of Lessor floor...... room number...... hereinafter this agreement call "Room for rental number" for staying.
 - The lessee must not disturbance and nuisance to other lessee in properties or Lessor
- 2. The Lessee "Room Number............. have one-year contract since made this contract (Respecting lessee not staying fully contract. Baan Tawan Rangsit Co.,Ltd will collect all the insurance payment immediately in any cases.
- 3. The Lessee are to pay the rent to Lesser for acquisition of rental agreement for 3 part
 - 3.1 Amount of money 7,800 Baht per month for rental. Payment must be pay on date 5 of next month. Starting from first month of staying until last month of agreement.
 - 3.2 Amount of money 8,000 THB (five thousand Thai baht) for insurance payment. In case the asset of Lesser are damaged covering fine that lesser have the right hold for insurance in the future. The lessee pays on contract date. (Vat is included).
 - 3.3 Emergency fund amount 12,000 THB (Ten thousand Thai baht)
- 4. The duties of lessor under this contract;
 - 4.1 The lessor must provide amenities and service as following;
 - two set of 3.5 feet mattress with bed or one set of 6 feet mattress with bed per one room, One set desk with chair, air conditioner 18000 BTU, shower heater, refrigerator, Television.
 - 4.2 The lessor has permission to inspection of property in room, which will be inform at least 3 day in advance.
 - 4.3 The lessor has permission to maintenance the room for ready to use constantly, which will be inform at least 3 day in advance. whereas emergency case, the lessor has permission to proceed immediately.

- 4.4 Damaged of public utilities which cause by installation error, damage overtime and emergency case which the lessor will responsible itself. Whereas the damaged from lessee, which lessee will responsible it themselves.
- 4.5 Upon expiration of this lease agreement, if the lessee doesn't inform to cancel a contract. The lessor will renew the contract automatically without any cost.
- 5. The duties of lessee under this contract;
 - 5.1 The lessee agrees to pay for all electricity and water follow usage unit. Electricity 5 baht per unit and water 25 baht per unit.
 - 5.2 The lessee will process the payment according to schedule after receive invoice until fifth on next month. Incidentally, if the lessee has overdue debt to lessor during this contract. The lessee must agree to pay the whole overdue debt. The lessor can demand interest during default at 7.5 percent per year since due payment.
 - 5.3 If the lessee has purpose to transfer the entire remaining portion of the lease to another person. The lessee able to transfer upon contract notice to lessor at least 1 month in advance.
 - 5.4 The lessee will follow the rules and regulations of the lessor for benefit of staying together.
 - 5.5 If the lessee has purpose to move out, the lessee must notice the lessor before 1 month in advance. The schedule to moving in-out are able at 8 a.m. 8 p.m. on 25^{th} until 5^{th} of next month.
- 6. The lessee is not allowed to bring all kinds of pets in rental area, which cause disturbing noise, smell to another lessee.
- 7. The lessee is not allowed to drink

 - 9.3 If the lessee still continues breech the agreement, which has already got caution according with the 8.1 and 8.2. The lessee still breaches the contract repeatedly, the lessor will reserve the right to intimating the agreement immediately. Moreover, the lessor has the right to claim for damaged in direct or related.
