## **Notification of Rangsit University** Regarding New Normal Learning Approaches during the Covid-19 Outbreak

With the Covid-19 situation becoming less severe and the steady decline in new Covid-19 cases as a result of the increasing rate of vaccinated people contributing to a significant decline in the daily death rates and to comply with the Order of the Pathumthani Province No. 10602/2564 and the approaches and the criteria for the resumption of the on-site operation of educational institutions under the supervision of the Ministry of Higher Education, Science, Research and Innovation, Rangsit University shall notify approaches for "new normal" learning management during the Covid-19 outbreak as follows:

- 1. All personnel, students, and visitors are required to complete the risk assessment form of the Department of Health, Ministry of Public Health, via the 'Thai Save Thai' application before entering the campus area. Only those with a 'normal' or 'low' risk shall be allowed to enter the campus area.
- All personnel, students, and visitors are required to scan the QR code via the 'Thai Chana' application and have a temperature check before entering each building and rescan it before leaving.
- 3. All personnel, students, and visitors are required to always wear face masks while in the campus area and sanitize their hands before entering each building.
- A minimum of 70% of students in class are required to be fully vaccinated or receive two vaccine doses; the number of students receiving one vaccine dose and unvaccinated students must not exceed 30% of the total number of students in class.
- 5. In each classroom, a distance of a minimum of 4 meters between each student is required to be maintained.

## 6. Lecture courses

- 6.1. On-site instruction shall be allowed. However, if there are students who need only online instruction platforms, lecturers are required to employ a hybrid of online and on-site instruction platforms.
- 6.2. Employing a hybrid of online and on-site instruction platforms, lecturers can borrow live streaming equipment by making a reservation for the equipment via https://itsc2.rsu.ac.th/bookaccessory/login or the OR code annexed to this Notification.
- 6.3. Learning management conducted via 100% online platforms shall be allowed if it is mutually agreed by lecturers and their students.
- 6.4. Students' online class attendance shall be recorded by lecturers.
- Laboratory and practice courses requiring outdoors space
  - 7.1. On-site learning management shall be allowed.
  - 7.2. Any learning activities conducted outside of the campus area shall comply with the orders of the province or area where they are conducted.
  - 7.3. Online learning activities shall be allowed upon mutual agreement acknowledged by students and their course lecturers.

- 8. Final examination
  - 8.1. Both online and on-site final examinations can alternatively be carried out upon mutual agreement acknowledged by students and their course lecturers.
  - 8.2. For on-site examinations, colleges/faculties/institutes are required to contact the Office of the Registrar for the arrangement for exam rooms.
  - 8.3. Any colleges/faculties/institutes that need their exam papers to be printed are required to submit the exam papers to the Office of Printing five business days prior to the examination date.
- 9. All outdoor activities with gatherings shall not be allowed. If inevitable, organizing colleges/faculties/institutes are required to receive permission to implement the highest screening measures as aforementioned.
- 10. In all cafeterias, a distance between each participant is required to be maintained. All participants shall refrain from having conversations with each other while eating.
- 11. Classroom and laboratory windows or doors shall occasionally be opened to improve natural ventilation.
- 12. All on-site gatherings in working or learning activities shall comply with the announcements and orders of the Center for the Administration of the Situation due to the Outbreak of the Communicable Disease Coronavirus (COVID-19).
- 13. All personnel and students shall comply with all additional notifications regarding approaches during the outbreak of COVID-19 issued by their supervising colleges/faculties/institutes.
- 14. All personnel and students shall strictly comply with preventive measures for Covid-19.

Any previous notifications issued against this Notification shall be substituted by this Notification until further notice.
